

Okotoks Agricultural Society Terms of Entry

Welcome to the Okotoks Agricultural Society. To ensure the best possible experience for all guests, we ask that you conduct yourself according to all applicable laws as well as all of the rules, guidelines and procedures of the Okotoks Agricultural Society (OAS), including those listed below, and those posted onsite.

Your access or attendance is conditional on your acceptance of the Rules. Thank you and we hope you enjoy your visit

- 1) Entry to the Okotoks Agricultural Society
 - a. The safety of our guests and staff is our primary concern. As such, no guest or member will be permitted to bring any of the following onsite
 1. Any Type of Weapon
 2. Illegal Drugs or Alcohol
 3. Motor cycles outside the parking area
 - b. Any other item that maybe considered dangerous, prohibited or which may otherwise impact the safety, security and/or enjoyment of our guests
 - c. We reserve the right to refuse entry or eject without refund any persons from Okotoks Agricultural Society who appear to be intoxicated (either drugs or alcohol)
- 2) The Okotoks Agricultural Society is a members only facility and requires a valid membership and waiver for the current year to use or facility or be under a valid rental agreement in place.
- 3) We endeavour to make your time at Okotoks Agricultural Society safe and enjoyable as possible. Nevertheless, please be aware that there are inherent risks with your visit. By entering or otherwise attending Okotoks Agricultural Society you agree that you voluntarily assume all risks and dangers connected to, associated with, or incidental to your presence at Okotoks Agricultural Society
- 4) You may be photographed, videotaped, and/or recorded during your visit to the Okotoks Agricultural Society. By entering OAS, you agree to each of the following terms and conditions
 - a. You consent to being filmed and/or otherwise recorded in connection to or as part of the OAS's journalistic, advertising, marketing, promotional, archival and/or security activities
 - b. Your consent to such photography, filming and/or recording and to any use, in any and all media throughout the world in perpetuity, without compensation to you, of your appearance, voice and/or name for the above noted purposes;
 - c. You understand that all photography, filming, and/or recording will be done in reliance on those consents given by you by entering OAS
- 5) All smoking is prohibited in OAS buildings and only allowed in designated areas
- 6) You voluntarily assume all risks and dangers connected to, associated with or incidental to your attendance at the OAS. Under no circumstances will the OAS be responsible for any loss, injury (including personal injury) damages, or liability that may arise out of or in any way connected to an Event or your attendance at OAS.

You hereby waive and release all claims or actions against OAS, or any sponsors, directors, officers, employees and volunteers of the OAS or its sponsors for any loss, injury (including personal injury) damages or liability that may arise out of or in any way connected to an Event or your attendance at OAS, regardless of whether such loss or injury damages or liability arise from negligence, libel, defamation, loss of privacy or otherwise.
